- A separate, clear, color, straight, scan of your passport, **jpeg** image.
- A separate a clear, color, passport style photograph, **jpeg** image. Head and shoulders against a white background, without glasses. A photo taken with a smart phone can be emailed as is.
- For business travelers, email a clear, color, straight scan of your business card, jpeg image

Validity and Fees:

Business visas are valid for one year with multiple entries for a maximum stay of 180 days. For US and UK citizens, the visa fee is \$102.50 and the service fee is \$75. For most other nationalities, the visa fee is \$82 and the service fee is \$75.

Tourist visas have three options and the prices are as follows for most nationalities:

- Valid for 30 days applying April to June Visa fee is \$11, Service fee is \$75
- Valid for 30 days applying July to March Visa fee is \$26, Service fee is \$75
- Valid for 1 year, multiple entries, up to 180 day stay Visa fee is \$42, Service fee is \$75
- Valid for 5 years, multiple entries, up to 180 day stay Visa fee is \$82, Service fee is \$75
